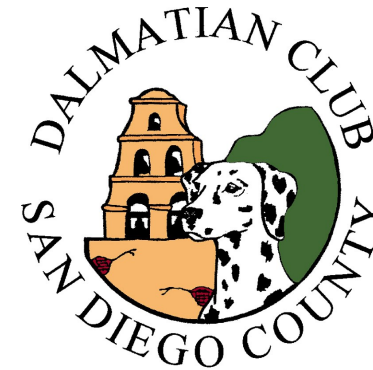

**BEST OF BREED**

The following categories of dogs may be entered and shown in Best of Breed competition. Dogs that are Champions of Record. Dogs which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship according to the owner's records. If at the end of the 90 day period, and the championship of the dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC.

**AWARDS OF MERIT**

The judge may, at their discretion, recall into the ring up to 10% of Best of Breed entries to receive Rosettes offered by the Dalmatian Club of San Diego County, Inc. These Rosettes are reserved for those quality animals the judge feels are worthy of final consideration for Best of Breed.

The puppy sweepstakes will be open to all Dalmatians, who on the day of the show will be six months and under 18 months of age. Each dog must also enter a regular class. Entries are to be made at the same time and on the same form as the entries for the regular classes. Sweepstakes classes should be indicated in the area marked “additional classes” on the entry form.

Veteran dog/bitch need not be entered in any other class at this show. Veterans competing in Sweepstakes may be spayed or neutered.

### **SWEEPSTAKES PRIZES– DIVISION OF ENTRY MONEY**

25% of total entry fees will be retained by the Club. The remaining 75% will be divided, adjusted for unfilled classes, and rounded to the nearest dollar as follows. Any prizes not awarded will go to the Trophy Fund

## PARADE OF TITLE HOLDERS

*(Parade of Titleholders will be held after the judging of the morning show.)*

This is a non-competitive Parade in which the dog may or may not be entered in the show; however, all dogs must have an AKC Registration number. Each entrant will receive a large rosette with the dog's name imprinted on it. Dogs must be pre-entered. Entry fee is \$10.00 per dog. You must complete the regular AKC entry form and enter the word PARADE in the box that says "Dog Show Class" if you are only entering the parade. If you are entering the conformation show then enter the class you are entering in the "Dog Show Class" box and then enter PARADE in the "Additional Classes" box. Next, you need to complete this Biography form and send this form to the onsite Show Secretary by the entry closing date of Wednesday, 5/31/23, noon PST. ## SHOW REGULATIONS

The show site will be accessible at 7:00 AM.

A recording fee of 50 cents will be required for each dog entered at any license or Member Club show, obedience trial or tracking test. This recording fee is to be collected by the show giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only (American Kennel Club Rules, Chapter 14, Section 2).

Entry fees are \$32.00 for regular classes., \$25.00 for Puppy Classes, 6-9 Months and 9-12 Months. \$25.00 for Stud Dog/Brood Bitch. Parade of Title Holders \$10.00. No charge for Junior Showmanship. These fees include a \$3.00 event fee and a 50 cent American Kennel Club recording fee. Sweepstakes entry fee is \$23.00.

Dogs entered in the American Bred Classes must have been whelped in the United States by reason of a mating which took place in the United States (American Kennel Club Rules, Chapter 6, Section 8).

Foreign dogs (dogs not whelped in the USA or Canada) are eligible for Puppy and Open Classes effective, January 1, 1985.

Make all checks and money orders payable in U.S. funds to DOG SHOW IN A BOX Checks or money orders must be sent with entries.

Telephone, Telegraph, fax and unsigned entries cannot be accepted. Entries not on official entry forms and photocopies of entry forms without Agreement and Rules on the reverse side of the official AKC entry form are not accepted.

Return checks do not constitute a valid entry fee. The Show Secretary will add a collection fee of \$35.00 to the amount of each returned check.

Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging may be excused.

Owners are responsible for errors in making out entry forms, whoever may make such errors. No entry fee will be refunded in event of such error or cancellation of entries after the published closing date. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by the veterinarian or judge or because of riots, civil disturbances or any other cause beyond the control of the Club.

In partial consideration of and as a condition to my right to attend or exhibit my dog(s) at this event, I release all members, officers, directors, and anyone associated with the DALMATIAN CLUB OF SAN DIEGO COUNTY from all liability for loss of property, illness or injury that might result from any activity associated with this event. I assume full responsibility for myself, my family members or guests and my dog (s) relative to any damages caused or sustained while at this event.

**AGREEMENT**

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.**

**INSTRUCTIONS**

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

# Junior Showmanship

## The regular Junior Showmanship Classes shall be:

**Novice.** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

**Open.** This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**Master.** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

**Junior, Intermediate and Senior** A Junior Class shall be for boys and girls who are at least 9 years old and under 12 years old on the day of the show. The Intermediate Class shall be for boys and girls who are at least 12 years old and under 15 years old on the day of the show. The Senior Class shall be for boys and girls who are at least 15 years old and under 18 years old on the day of the show.

**Best Junior Handler.** A club offering Junior Showmanship must offer Best Junior Handler. The Junior Handler placed first in each of the regular Junior Showmanship Classes, if undefeated in any other Junior Showmanship Class at that show, shall automatically be eligible to compete for this prize.

**Reserve Best Junior Handler.** Specialty Club has the option to offer Reserve Best Junior. If a prize is offered, it must be described in the premium list in accordance with Rules Applying to Dog Shows Chapter 5, Section 5.

After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.
