DIRECTIONS TO SHOW SITE

PLEASE NOTE: There is construction on I-275 between I-96 and I-94. Please allow extra time or consider alternate routes. See <https://mdotiboss.state.mi.us/MiDrive> for up-to-date road construction information and maps.

FROM THE NORTH: I-75 south to S Huron River Drive (exit 26). Turn left on S Huron River Drive and then left again almost immediately onto Carleton-S. Rockwood Rd. Follow Carleton S. Rockwood Rd for about 6 miles, the VFW hall will be on your left after you pass over I-275.

FROM CANADA (VIA WINDSOR): Take 401 West to Ambassador Bridge. Once over the bridge, follow signs for I-75 south to S Huron River Drive (exit 26). Turn left on S Huron River Drive and then left again almost immediately onto Carleton-S. Rockwood Rd. Follow Carleton S. Rockwood Rd for about 6 miles, the VFW hall will be on your left after you pass over I-275.

FROM THE SOUTH: Take I-75 North to I-275 North (exit 20) Take I-275 to Exit 5, turn left over the freeway and the VFW hall will be on the left.

FROM THE MONROE FAIRGROUNDS: Take M-50 East to US 24 North. Turn Right on US 24 North, and go north to I-275 (you will bear left at the intersection with M-125). Take I-275 North about 3 miles to Exit 5 and turn left over the freeway, the VFW will be on the left.

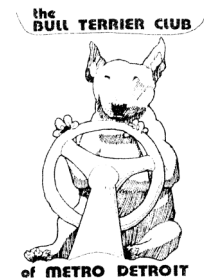
