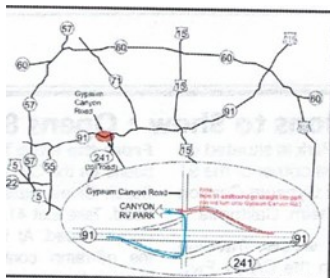


Directions to Show • Opens 8:00 am

Canyon RV Parks is situated on the Northwest corner of the 91 Freeway and Gypsum Canyon Road in Anaheim, California. **From the West:** Traveling eastbound on the CA-g1 Fwy, pass Weir Canyon Road. Take Exit 41 for Gypsum Canyon Road. Turn left at the bottom of the off ramp. Pass under the freeway and turn left at the signal. This will lead you right into the entrance. Specialty location is to the right after entering the park. **From the East:** Traveling west-bound on the CA-91 Fwy toward Beach Cities, pass Green River Road. Take Exit 41A for Gypsum Canyon Rd, At the bottom of the off ramp continue straight through the signal into the park entrance. Specialty location is to the right after entering the park.
