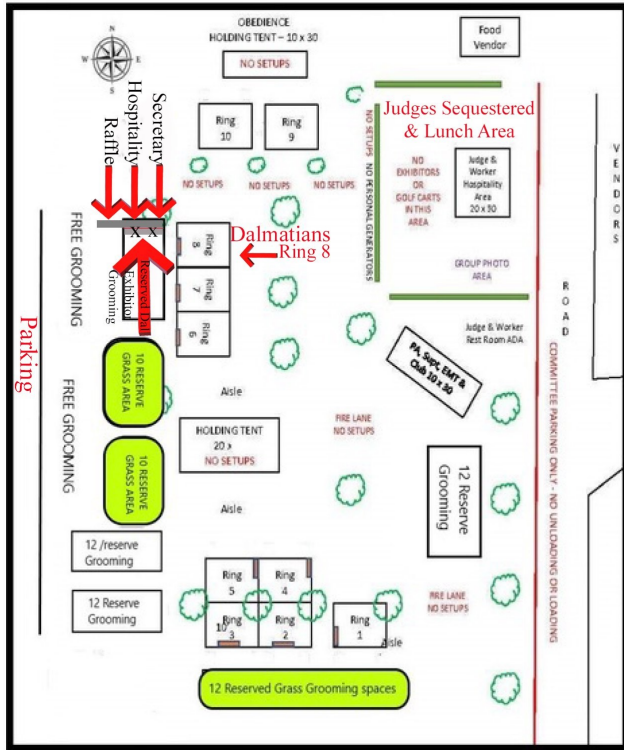


DIRECTIONS TO SHOW GROUNDS:

From I-5 NORTH OR SOUTH Take Hwy 78 East to I-15 North. Next Follow I-15 North or South. Take El Norte Parkway (first exit) go east 4 ½ miles to Valley Parkway. Turn left, continue on Valley Parkway which will become Valley Center Road go 10 miles to the 4th stoplight at Lake Wolford turn right. Continue 2.2 miles to four way stop sign at Woods Valley turn Right. Bates Nut Farm will be on your right.
