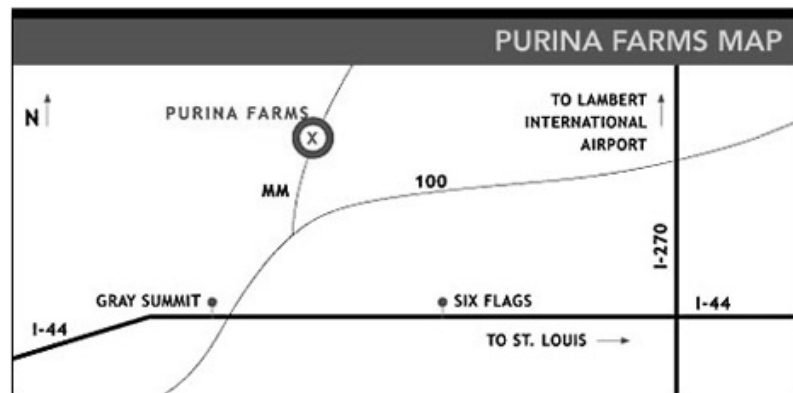

DIRECTIONS TO DR. WILLIAM JONES OFFICE: From Purina Farms entrance, turn right on Highway MM, then right on Highway 100, cross over Interstate 44, then left on US-66W-Osage Street for 2.7 miles to Flier Drive, turn right. Pacific Animal Hospital is 450 West Flier Drive – first building on the right.

DIRECTIONS TO THE ANIMAL EMERGENCY CLINIC: Take Hwy I-44 East to Big Bend Rd. Turn right on Big Bend. The Emergency Clinic is on the left-hand side.
