If you are starting from East of Palm Springs— take the I-10 heading West, take Exit 126 for Date Palm Dr, turn Left on Date Palm. Go to Vista Chino and turn Right. Go 5.5 miles to corner of Vista Chino and N Indian Canyon. Margaritaville is on that corner. If you are starting from West of Palm Springs— take the I-10 heading East, take Exit 111 for CA-111 toward Palm Springs. Continue about 10 miles to W Vista Chino and turn Left. In 350ft turn Right onto N Indian Canyon Drive. Margaritaville is on your Right.
